SEMINAR FOR STUDENTS STUDYING COURSES DELIVERED IN ENGLISH

This seminar will be delivered by Dr Alla Pozdnakova (alla.pozdnakova@jus.uio.no), Centre for European Law.

The course is particularly useful to the following categories of students:

- (i) Erasmus and exchange students from other countries in Europe with two or more years of studying law in their home Universities;
- (ii) Norwegian law students who have studied less than 3 years of their master degree and who are required to study at least one elective course which is delivered in English;
- (iii) Students who are not law students but studying for a bachelor degree.

1. OBJECTIVES AND AIMS OF THE SEMINAR

The objective of the Seminar is to introduce Visiting and Norwegian students to legal systems particularly the EU legal order; explain the relationship between Norwegian domestic law, European Union, European Human Rights Law and International law. The objective of the Seminar is also to give students a general introduction into methods of law study such as case-law method and to improve their understanding and practical skills of interpreting and applying international, EU and national law sources. Students are also given an introduction into syllabus, goals and reading requirements, albeit at the general level.

The Seminar is organized as lectures, group work and discussions where students will discuss a topic or article assigned to all the BA students and an assignment addressed to specific law disciplines at the BA level.
