

3.1 The extent of the duty of disclosure

- o NP Cl. 3-1: All relevant information
 - o = Active duty of disclosure
 - o # Passive duty of disclosure
 - o The difference
 - o The concept of relevant information

3.2 The time of the duty of disclosure

- o NP Cl. 3-1
- o Concerns
 - o Time of the factual circumstances
 - o Time of good faith
- o Factual circumstances: When the contract is entered into
- o Good faith: Duty to make corrections



3.3 Who has a duty of disclosure

- o Starting point:
 - o The person effecting the insurance, NP Cl. 3-1.1
 - o No general duty for the assured
- o NP Cl. 8-2: Special rule for the assured
- o Identification with agents/brokers

3.4 The sanctioning system

- o Complicated system:
 - o Different sanctions:
 - o Contract not binding
 - o No liability for damage
 - o Cancellation
 - o Depending on the degree of fault:
 - o Fraud
 - o Negligence
 - o Innocent breach

3.4 The sanctioning system

- o Fraud; NP Cl 3-2.
 - o The contract is not binding
 - o Right to cancel all other contracts
- o Negligent or intentional breaches, § 3-3:
 - o Ins. would not have been accepted not binding
 - o Otherwise:
 - o No liability if causation
 - o cancellation
- o Innocent breach, Cl 3-4
 - o Cancellation

3.4 Conditions to invoke sanctions

- o NP Cl. 3-5
 - o No knowledge
 - o Decisive risk factor
- o NP Cl. 3-6
 - o Notification

Duty of disclosure, question

When shipowner A effected hull insurance with AS Insurance he told the insurer that the ship Unlucky was registered in NIS, but not that Unlucky sailed with Cypriotic crew.

The insurer did not accept Cypriotic crew Is this a breach of the duty of disclosure?

If yes: what would the sanction be?

Unlucky was on bare boat charter and the owner A - who effected the insurance - did not know about the nationality of the crew.

Would this be a breach of the duty of disclosure?

If yes: what sanction

What if the charterer was co-insured?

4 Alteration of risk

- o Characteristic features
 - o Extension of duty of disclosure
 - o Correspond to "bristende forutsetninger"
- o Two sets of rules
 - o General regulation
 - o Special regulation

4.1 NP: general regulation

- o NP Cl. 3-8 to 3-13
- o The concept of alteration of risk, NP Cl. 3-8, 1
- o Shall be deemed as alteration of risk, NP Cl. 3-8, 2 Change of
 - o State of registration
 - o Technical/maritime operator
 - o Classification society

4.1 NP: general regulation

- o Alteration of risk caused/agreed to by the assured:
 - o No liability, Cl. 3-9
 - o Cancellation, Cl. 3-10
- o Alteration of risk not caused/agreed to by the assured;
 - o Notification, Cl. 3-11
 - o If not, Cl. 3-9 applies
 - o + Cancellation, Cl. 3-11

Alteration of risk, question

A vessel was insured registered in NIS but with Norwegian captain and first mate. This was informed to the insurer. During the insurance period the assured changed to Cypriotic captain and first mate.

Is this an alteration of risk? If yes; what is the sanction?

4.3 NP: The special regulation

- o Classification
- o Change of ownership
- o Illegal activities
- o Trading limits

4.3.1 Classification, NP Cl. 3-14

- o Expressed as a warranty:
- o The ship shall be classified when the insurance commences
- o Loss of class = the insurance terminates regardless of
 - o causation
 - o fault
- o Similar regulation in many other countries

Question

- o The ship Classy was insured with AS No Way and classed in DNV. The owner requested the class to be cancelled in order to transfer the class til Lloyds. Now Way was not notified. After cancellation, but before the new classification was final, Classy sustained a casualty.
- o Is No Way liable for the casualty?
- o The assured claimed that No Way knew of the transfer. Is this relevant?

4.3.2 Change of ownership

- o NP Cl. 3-21
- o The insurance terminates immediately
- o Reason: the importance of ownership
- o Change of ownership # change of shareholder structure

4.3.3 Illegal activities

- o Starting point: No liability for losses caused by illegal activities unless the assured in good faith, NP Cl. 3-16, 1
- o If the ship is used primarily for illegal activities, the insurance terminates, Cl. 3-16, 3.

Question

- o The crew onboard the ship New Venture smuggled opium from Malaysia to Norway without the assured's knowledge. During the voyage, New Venture grounded due to heavy weather.
- o Is the insurer liable for the damage?
- o Would it matter if the smuggling had taken place for a period of 1 year before the casualty?


4.3.4 Trading limits

- o NP Cl. 3-15;
 - o Ordinary areas,
 - o conditional areas and
 - o excluded areas
- o The areas defined in enclosure to the Plan

4.3.4 Trading limits, Cl. 13-15

- o Ordinary trading areas, (1)
- o Conditional areas, (2);
 - o sailing subject to additional premium.
 - o Sanction extra deductible
- o Excluded areas (3);
 - o Insurance ceases to be in effect
 - o until the ship leaves the excluded area



5.1 Overview

- o Scandinavian invention
- o Not used in other systems
- o Anglo American parallel: warranties
- o Powerful weapon for insurer
- o The traditional system: seaworthiness and safety regulations as parallel rules

5.2 The concept, Cl. 3-22

- o What: Measures for the prevention of loss
- o May be issued by
 - o public authorities,
 - o the insurer
 - o the classification society.
- o Includes
 - o periodic surveys
 - o Ice class regulation prescribed by the class

5.2 Sanction, Cl. 3-25

- o Sanction 1; No liability Cl. 3-25
 - o Negligence, Cl. 3-25 (1)
 - o Causation, Cl. 3-25 (1)
 - o Burden of proof shifted, Cl. 3-25 (3)
 - o Breach of special safety regulation results in extended identification, Cl. 3-25 (2)

5.3 Sanction, Cl. 3-27

- o Sanction 2; Cancellation, Cl. 3-27
- o 14 days notice
 - o (a): Not in compliance with a technical or operational safety regulation
 - o (b) safety regulation of material significance

Safety regulation, question 1

A vessel was captured by pirates 200 nautical miles outside the coast of Somalia. IMO has established guiding lines advising that all vessel sails more than 400 nautical miles off the coast of Somalia.

Is this a breach of a safety regulation? If yes, what is the sanction?

Safety regulation, question 2

A vessel grounded whilst sailing in shallow waters. It was established that the ISM certificate had been withdrawn because of failures in the safety management system for the ship.

Is this a breach of a safety regulation?

If yes, what is the sanction?

5.3 NP: Ships laid up

- o NP Cl. 3-26: Laid up plan required
- o The rules on breach of safety regulation applies if:
 - o No lay up plan drawn up
 - o laid up plan not followed

6 Casualties caused by the assured

- o The concept: the casualty is caused by an act or omission by the assured
- o Distinction between degree of fault:
 - o Intent
 - o Gross negligence
 - o Ordinary negligence

6.1 Intent, Cl. 3-32 and 3-34

- o The concept of "intent"
- o Sanction 1: No claim, Cl. 3-32
- o Sanction 2:
 - o Termination of this contract without notice, Cl. 3-34, 1.
 - o Termination of other contracts by giving 14 days notice, Cl. 3-34, 2

6.2 Negligence

0-

- o Gross negligence:
 - o Sanction 1; Cl. 3-33: 100 % liability according to

o the degree of fault and

- o other circumstances,
- o Sanction 2; Cl. 3-34, 1, 2:
 - Termination,14 days notice
- o Ordinary negligence: No sanction

Casualties caused, question

A vessel was captured by pirates. The master had failed to follow Best Management Practises in regard to lookout before the attack and therefore was not able to take preventive measures or call for help.

Is this gross negligence?

If so - what is the sanction?

7 Notification and salvage measures

- o Duty to notify
- o Duty to salvage
- o Sanction



7.1 Duty to notify Cl. 3-29

- o if loss has occurred or threatens to occur
- o without undue delay/promptly
- o keep informed
- o + notify of maritime inquiry/surveys

7.2 Duty to salvage, Cl. 3-31

- o Reasonable measures to avert/minimize a loss
- o Follow insurer's instructions



7.3 The sanction, Cl. 3-31

- o No liability
 - o if fault (intent or gross negligence) and
 - o only for losses that would otherwise not have been incurred










8 Identification, Overview

- o The need for rules
- o The problems:
 - o the person effecting insurance and his helpers
 - o the assured and his helpers
 - o the assured and the person effecting the insurance
 - o the assured and co-insured/co-ownerssue of identification











8.1 Person effecting the insurance and his helpers

- o Full identification
- o No express provision in the conditions.
- o Follows from ordinary contract law




8.2 The assured and his helpers

- o Starting point, Cl. 3-36, 2: Identification if helper is
 - o An individual/organization
 - o With authority delegated from the assured
 - o Concerning functions of material significance for the insurance
 - o And made a mistake under the performance of these functions
- o If the master/crew should be in the mentioned position, the same holds for these




8.2 Between the assured and his helpers


- o No identification in other circumstances
- o Includes master/crew in connection with their service as seamen, Cl. 3-36, 1
- o However: Specific provisions, i.e. in Cl. 3-25,2



8.3 The assured and the person effecting

- o Cl. 3-38: Full identification
- o Holds also if the person effecting the insurance uses a helper;
- o i.e. Identification in two steps





8.4 Assured + co-insured/co-owner

o Cl. 3-37:

- o Starting point: No identification
- o Exception if the co-insured/co-owner has overall decision authority for the operation of the ship
