<u>JUS5850 – International Trade Law</u>

The language of examination for this course is English: students may answer in English ONLY, answers in any other language than English will be given a F (F for fail).

Part I

Peter Hill was an enthusiastic globetrotter, and after having spent half a year in China he came back to his home country, Elbonia, with new ideas on how to promote healthy transportation. He wanted to import electrical bicycles (e-bikes) from China. The model he wanted to import had a maximum speed of 40 km per hour and could go a maximum of 80 km when fully charged. Elbonia is a mountainous country and most of the roads are considered to be narrow and dangerous. Elbonia relies heavily on hydropower for production of electricity; currently 95 % of electricity consumption is based on hydropower. Statistics show that only 1 % of the population uses bicycles daily while as many as 30 % use motorbikes and 60 % use cars.

Elbonian producers of bicycles were skeptical to the idea, and proposed that the Elbonian Ministry of Transportation adopt the following measures:

- 1) a tax on e-bikes corresponding to the tax on motorbikes (motorbikes were subject to a 20 % specific ad valorem tax due to their CO_2 emissions, there was no specific tax on bicycles),
- 2) a regulation requiring e-bikes to be sold only by retailers that also sell motorbikes (there are currently 30 such retailers in Elbonia), and
- 3) a regulation setting the maximum speed of e-bikes to 30 km per hour.

The Elbonian Bicycle Producer Organization was member of the American Bicycle Producer Organization, which had recently adopted a resolution stating that e-bikes should have a speed limit of 30 km per hour. The American Organization had national bicycle producer organization members from all Latin American countries.

You work as legal adviser for Elbonia's Ministry of Trade and Industry. Your Ministry receives a request from the Ministry of Transportation that asks whether any of the proposed measures could be in violation of







Elbonia's obligations under the WTO Agreement. The relevant part of Elbonia's schedule of specific commitments on services is set out in the annex.

Part II

Discuss the following statement: "The WTO Appellate Body emphasizes the 'ordinary meaning of the wording' in its treaty interpretation. This approach to treaty interpretation contributes to the willingness of countries to comply with decisions of the dispute settlement mechanism of the WTO."
