The exam will be a digital home exam conducted in the examination system Inspera. You must submit your answer through Inspera. Your answer must be converted to PDF format before you upload it on Inspera. You can only submit one (1) PDF file.

- Font: Times New Roman, size 12
- Spacing: 1,5
- File format: PDF
- The front page of your paper should include: Title, course code, and word count (NOT your name!)
- Inspera closes automatically when the exam time runs out. Please reserve enough time to ensure that your answer is successfully uploaded and submitted in Inspera.
- It is your responsibility to save your work throughout the exam. Make sure you save and take necessary backups.

Please be mindful of the maximum word count for your exam. Papers that exceed the word limit will not be accepted. Footnotes should be included in the word count of the main text. The word count does not include: the front page, summary, table of contents, and references (bibliography) (if relevant for your paper).
